**A1 TOP CLASS** The vehicle must be in excellent condition with bodywork/chassis free from rust. The vehicle's components should be free from any but trivial faults and should work efficiently.

**A2 AVERAGE** The vehicle should be in good working order, capable of regular use and satisfying an MoT Test requirement. The bodywork/chassis must be free of extensive rust and/or damage.

**A3 SERVICEABLE** The vehicle must be in a roadworthy condition and be capable of satisfying an MoT Test requirement. A considerable amount of work may be required to make the vehicle condition A2 or better.

- 5) TSSC Insurance Panel members appoint no agents.
